MEMBERSHIP APPLICATION FORM

ACKNOWLEDGMENT OF RISKS, DANGERS AND OBLIGATIONS

1. I ACKNOWLEDGE that motorcycle sport is dangerous and that by engaging in the sport and participating in any event, I take and am exposed to certain risks and dangers and am under certain obligations as follows:

(a) Persons under the age of 18 must have parent guardian consent to participate and to sign the indemnity form.

(b) that I may be injured, physically or mentally and may be killed;

(c) that my machinery or equipment may be damaged, lost or destroyed;

(d) that other participants may ride dangerously or with lack of skill;

(e) that track or event conditions may be hazardous and may vary without warning or predictability;

(f) that organisers, officials, landowners, venue operators and any agents or representatives of those in charge of events are frequently obliged to make decisions under pressure of time and/or events;

(g) that any policy of insurance of or in respect of my life or physical or mental health may be avoided;

(h) that there may be no or inadequate facilities of treatment or transport of me if I am injured;

(i) that I have an obligation to myself and to others to participate safely and within the rules of the event;

(j) that I will not participate in the event (as a rider or a volunteer) whilst under the influence of drugs or alcohol (as defined in the Qld road rules).

INDEMNITY GIVEN TO LANDOWNERS & ORGANISERS

In respect to death, injury, loss or damage to third parties.

2. IN CONSIDERATION of the acceptance of me as an entrant in the event, **I AGREE TO INDEMNIFY** the landowners and organisers and each of them in the following manner

(a) that I participate in the event at my sole risk and responsibility;

(b) that I accept the venue as it stands with all or any defect hidden or exposed .

(c) that I indemnify and hold harmless the landowners, organisers, their respective servants, agents or officials against actions or claims which may be made by me or on my behalf or by other parties for or respect of or arising out of my death or any injury, loss or damage caused to me or my machinery or equipment whether caused by negligence, breach of contract, or in any other manner whatsoever.

3. I confirm that I have read and understood the club's **Information Sheet** and **Code of Conduct**, and agree to abide by the Code of Conduct.
